

Re: St Luke's Church, Reigate

Following my recent visit to site, I now have pleasure in submitting the attached revised quotation for your consideration.

The proposal is broadly the same as the quotation presented in November 2020. As before, the existing boiler would be retained but the system of pipework and radiators in the worship and vestry areas would be replaced.

The radiator count was 15 but this has been increased to 19, new pipework in the church would be connected to existing pipework leading back to the boiler. Some of the existing pipework is inaccessible and as such cannot be altered. We therefore cannot accept any liability for the condition of this existing pipework.

From our experience this specification is usually provides enough detail to allow the faculty process to begin (if applicable) or any applications to be made to grant making bodies or organisations offering funding. However, should you have any queries then please do not hesitate to contact me.

System Design - Rads and pipework in the worship and vestry areas only

The proposed scheme will re-use the existing boiler plant but the existing pipework in the worship and vestry areas will be replaced to form a new two-pipe system serving 19 new radiators; this new pipework will be connected to existing pipework. Unfortunately, the existing pipework is inaccessible as it is encased in concrete and we therefore cannot accept any liability for the condition of this existing pipework.

An air and dirt separator will be installed to constantly filter the system and remove air automatically. A new pump will also be installed to ensure that the circulation and flow of the water is correct.

Whilst great care is taken in designing the scheme to provide the best possible solution to your heating needs, you should be fully aware that when connecting new, modern equipment to an existing system, we cannot accept any responsibility for the suitability or integrity for any part of the retained system, any problems that may occur with the retained areas are outside our guarantee.

Radiators x 19

The radiators used within this scheme are high quality, triple panelled, triple finned radiators that can be either wall-mounted or floor-standing, depending on location. If a radiator is to be mounted in front of important timber or stone, or in front of loose pews, then the units may be floor-standing using special brackets.

Each radiator will be fitted with a tamper-proof lockshield valve at the return end and a full-flow, wheel head valve at the flow end. We do not usually fit thermostatic radiator valves in open areas as they can easily be tampered with, thus affecting the overall performance of the system; however, if a radiator is to be in an enclosed area, such as a vestry, then the wheel-head can be replaced with a radiator thermostat.

The standard colour of the radiators is Warm White; radiators can be colour coded to match the surroundings, but this would add to the cost. If an alternative colour is preferred, this would need to be confirmed in writing before the commencement of work.

A radiator schedule can be provided before and work is carried out and your architect's drawing can be marked up with the size and location of the radiators.

Pipework

The system will consist of a boiler plant and interconnected heat emitters in a two pipe manner. The pipework will be medium-grade steel, finished with red oxide primer, the pipework will be screwed and threaded and use malleable fittings. All pipework will be clipped at regular intervals.

Where pipework passes through walls, it will have a protective sleeve. Unless otherwise specified the pipework will run at low level underneath the radiators and would cross any doorways as detailed on site.

Any pipework that passes under floors, through voids or in the immediate boiler vicinity will be insulated. If the pipework passes close to the organ, this will also be lagged.

Boiler

The scheme includes for the retention of the existing boiler. The quotation assumes that it has sufficient capacity to support the new system. We do not accept responsibility for the worthiness or integrity of the existing boiler and it is excluded from our guarantee.

Fuel Supply

As we are simply connecting new radiators to an existing boiler, we will not inspect the incoming fuel supply, the quotation assumes that the fuel supply is adequate to cover the new installation.

Control (worship and vestry areas only)

The worship and vestry areas will be controlled by our 'Churchwarden' control system, an intelligent control system manufactured in the UK.

The system is designed to maximise fuel economy by calculating the best time to switch on the heating. All you need to do, is enter the times of occupancy and the controller will decide the best time to switch the heating on, in order to get to the required temperature by the right time.

For a small additional cost, some versions of the 'Churchwarden' have a remote access facility, this allows control of the heating via an I-phone, I-pad, pc or android device. Please note that this model depends on a good Wi-fi connection.

Electrics

The scheme includes all associated electrical work required to install the new controls and uses FP200 cable.

The quotation assumes that your incoming electric supply is adequate and up to current regulations and will support our system.

Any alterations needed to this supply or to the distribution board are not included in the quotation and will have to be addressed either by your own electrician or by or electrician at additional cost.

Testing

The system will be filled and pressure tested to ensure that the water side of the installation is sound. Inhibitor will be added to the system water to ensure that the ph balance is in accordance with the boiler manufacturer's recommendations. The boiler will not be tested.

Performance

As we are simply replacing the radiators, the existing boiler plant will not be tested by our engineers. However the performance of the system is dependent upon the optimum efficiency of the boiler plant, it is strongly recommended that you contact your service engineer in order to arrange a service to ensure the boiler is running efficiently.

Guarantee

The equipment we have supplied and installed is guaranteed for 12 months which is the manufacturer's usual guarantee. The guarantee does not cover any part of the retained system.

If you have any problems with the installation during this period then please contact the office directly.

After Sales Service

After sales service is important to us; if you call our office you do not have to choose from a long list of options, you will speak directly to one of our staff and we will endeavour to deal with any queries or problem as quickly as possible.

Removal

The quotation includes for the removal of radiators and pipework at low level in the worship and vestry areas. Other areas of the system are excluded from removal. Any redundant pipework that is under the floor, in floor ducts or in any inaccessible areas will be abandoned in situ. Pipework or heat emitters at high level will be isolated and disconnected at low level but again left in situ.

Within the price of the scheme it has been assumed that our engineers will clear the scrap from site. We can however leave the scrap for you to dispose of as you wish but we would need written confirmation of this prior to any works commencing detailing the disposal arrangements, it would then be the responsibility of the church to ensure both the security of the removed material and that the scrap was removed from site quickly and safely as any un-cleared scrap could present a health and safety hazard to both engineers and visitors to the church.

Any remedial work required as a result of removing the existing equipment or from installation of new equipment is not included in the quotation.






